WITHOUT PREJUDICE to the generality of my/our aforesaid indemnity, I/WE HEREBY AUTHORISE you to set off any money in your possession belonging to me/us or to debit against me/us in any account which I/we now or may hereafter have with you any sum or sums of money which you may pay for or in respect of your aforesaid Bank Guarantee, upon giving sufficient written notice to you.

I/WE HEREBY CONFIRM AND DECLARE that there is no claim arising in relation to the Project and no event of non performance has taken place from the Effective Date until issuance date of the Bank Guarantee.

AND IT IS HEREBY AGREED AND DECLARED that in the event of this Indemnity being signed by two or more persons each and all such persons signing the same shall be deemed to be JOINTLY AND SEVERALLY liable to you there under.

I/WE hereby agree that notwithstanding any clause in the Bank Guarantee as to the effective period thereof, my/our obligations to indemnify you or provide adequate securities hereunder shall continue so long as the original copy of the Bank Guarantee or sufficient written notification by the holder thereof is not delivered to you.
