You are then requested to deliver to us the invoices and the drafts of the second beneficiary. If you choose to negotiate the documents, you are to forward to us your cheque /Credit Advice for the amount by which our draft exceeds the amount of the draft of the second beneficiary provided that our draft and invoices comply with the conditions of the credit, in the event we fail, at your demand, to deliver to you, the new draft and invoices as specified above, you are authorised to dispose of the invoices and other documents accompanying the drafts of the second beneficiary in accordance with instructions from your principals without any responsibility on your part for payment of the difference between the amount of the second beneficiary's draft and the amount authorised to be paid under the original advice of Documentary Credit.

It is understood that you shall not be responsible for the description, quantity, quality or value of the merchandise shipped under the Transferred Credit, or for the correctness, genuineness or validity of the documents, or for the general or particular conditions stipulated in the documents, or for any other Cause beyond your control.

The Transferred Documentary Credit is subject to the Uniform Customs and Practice for Documentary Credits currently in forced.
