GROUP WHISTLE BLOWING POLICY

IF SOMETHING'S WRONG, SPEAK UP! By speaking up, we are holding the wrong-doers accountable

Policy Statement

Group Whistleblowing Policy (GWBP) aims to urge you to speak up against wrongdoings and Bank Islam Group (the Group) is committed to ensure the highest standards of ethical, integrity, moral and legal business conduct and practices. The Group is also committed to transparency and accountability in all aspects of its business and operations. These commitments shall also align with the Group in championing Shariah values and to maintain the standards of Shariah principles.

Objective of the Policy

This Policy is to provide an avenue for all employees of the Group and members of the public to disclose any improper conduct in accordance with the procedures as provided for under this Policy and to provide protection for employees and members of the public who report such allegations.

Applicability of the Policy

This Policy shall be applicable to all employees of the Group, senior management, directors, including its subsidiaries and any other individuals who have established a relationship with the Group including, but not limited to, agents, consultants, contractors, vendors, suppliers, and service providers.

Scope of Reporting

A disclosure of an unethical conduct and malpractice that may cause potential risk to the Group shall include but not limited to the following issues:

a) Bribery, receiving and/or giving kickbacks;

- b) Fraud or dishonesty;
- c) Abuse of position;
- d) Abuse of the Group's property and information;
- e) Forgery or alteration of any documents belonging to the Group, its customers, another financial institution(s), or agents of the Group
- Embezzlement or theft; **f**)
- g) Conflict of interest;
- Any other actual or suspected breach of any other laws; h)
- Breach of the Bank's Code of Ethics and Conduct and any other policies; 1)
- Breach of BNM policy documents;
- Abetment to commit any of the above wrongdoing; k)
- Detrimental action taken against WB or persons closely associated with WB; and
- m) Such other matter that may breach the Group's and/ or subsidiary's Code of Ethics and Conduct and/ or actions that may damage or negatively impact the Group's branding.

Members of the public are also encouraged to whistleblow should they have discovered any incidences above, where relevant.

Confidentiality and Protection to Whistleblower

Whistleblower (WB) is encouraged to identify himself/herself when submitting a disclosure report. If the identity is not revealed, the Group has the discretion whether to proceed with the investigation or reject the anonymous disclosure. All concerns and disclosure made through this procedure will be treated in confidence and all effort will be made as not to reveal WB's identity unless otherwise agreed. The Group shall take all necessary measures to ensure that the identity and personal information of the WB shall be always protected and kept confidential. Upon making the disclosure in good faith, the WB will be protected from any reprisal and/or detrimental action within the Group as a direct consequence of his or her disclosure.

To Whom to Disclose

Any disclosure of improper conducts depending on the identity of the person being complained against, shall be made to any of the relevant Designated Person (DP) through the email channels as

A WB who wishes to withdraw his/her disclosure is required to write to the respective DP as stated above, together with supporting reason(s) for the withdrawal.

Maintenance of Documents

All documents relating to whistleblowing (i.e. whistleblowing reports, investigation documents etc.)

Alternative Avenues to Whistleblow

Alternatively, a WB may also lodge a report to the Bank Negara Malaysia, Polis Diraja Malaysia, Malaysian Anti-Corruption Commission or any other enforcement agency; if he/she so wishes.
