#### **TERMS AND CONDITIONS**

## **Organiser & Qualifications**

- This "Wave & Win" Contest ["Contest"] is jointly organised by 7-Eleven Malaysia Sdn Bhd (Registration No: 198401008445 (120962-P)) and Payments Network Malaysia Sdn Bhd (Company No: 2000801035403 (836743-D)) (PayNet) [collectively referred to as "The Organiser"].
- 2. This Contest is open to all MyDebit Automated Teller Machine ["ATM"] card holders issued by participating financial institutions authorising MyDebit services in Malaysia. The mentioned card holders must be a permanent resident in Malaysia or a Malaysian citizen who is 18 years of age and above and has a valid identification document during the Contest Period ["Participant"].
