Revised Stamp Duty for Cheque

7 February 2025

Dear Valued Customer,

Please be informed that effective **1 January 2025**, the stamp duties related to cheque-related instruments have been revised, as outlined in The Finance Act 2024, which was published on 31 December 2024.

Frequently Asked Questions (FAQs) on Stamp Duty changes:

- Why did Bank Islam increase the price on stamp duty for Cheque Book Issuance and Deposit of Foreign Cheque?**
This applies to all financial institutions as outlined in The Finance Act 2024 which was published on 31 December 2024, and the stamp duty rate changes took effect from 1 January 2025 onwards.
- Can I request an exemption of stamp duty?**
No. Stamp duty is payable to Lembaga Hasil Dalam Negeri (LHDN).
- Is the RM1.00 stamp duty charged per cheque leaf or per cheque book?**
It is charged per cheque leaf. For example, every cheque book is issued with 50 pieces of cheque leaf and customer would require to pay RM50.00 as stamp duty for cheque book issuance.

Soalan Lazim (FAQ) mengenai Perubahan Duti Setem:

- Mengapa Bank Islam menaikkan kadar duti setem bagi Pengeluaran Buku Cek dan Deposit Cek Luar Negara?**

Perkara ini melibatkan semua institusi kewangan. Akta Kewangan 2024 telah diterbitkan pada 31 Disember 2024, dan perubahan kadar duti setem telah berkuat kuasa mulai 1 Januari 2025.
- Bolehkah saya memohon pengecualian duti setem?**

Tidak. Duti setem perlu dibayar kepada Lembaga Hasil Dalam Negeri (LHDN).
- Adakah duti setem RM1.00 dikenakan berdasarkan setiap helai cek atau setiap buku cek?**

Duti setem dikenakan berdasarkan setiap helai buku cek. Sebagai contoh, setiap buku cek mempunyai 50 helai buku cek, dan pelanggan perlu membayar RM50.00 sebagai duti setem untuk pengeluaran buku cek.
