

1. Who is entitled for the free access to Plaza Premium Lounge?

- The following are the “Eligible Customers” who will enjoy complimentary access to selected Plaza Premium lounges at airport worldwide from 1 January 2024 until 31 December 2025:

2. What is my entitlement if I have more than one card?

- The entitlement is for each card. If you are Bank Islam World Mastercard & Visa Infinite Credit Card-i cardholder, you are entitled for 3 times complimentary access for each card.

3. How can I enjoy the free access to Plaza Premium Lounge?

- Eligible Customers are simply required to present his/her Bank Islam Credit Card-i to enjoy complimentary access to Plaza Premium Lounge.

4. Can I use one Bank Islam Mastercard World or one Bank Islam Visa Infinite for 2 complimentary entries for 2 persons at the same time for the Plaza Premium Lounge access?

- No, you only allowed to use one Bank Islam Mastercard World Credit Card-i or one Bank Islam Visa Infinite Credit Card-i per person, per visit.
- Only cardholders are entitled to use the complimentary access. The card cannot be used by any other person besides the cardholder.

5. What happens if I have used the facilities more than 3 times?

- You will be informed at the front desk once you have exceeded your complimentary access to Plaza Premium Lounge for each card (if any).
- Cardholders are entitled to a 20% discount on the walk-in price after exceeding complimentary access to Plaza Premium Lounge.

6. Can I bring a guest along?

- The privilege is only applicable to Eligible Customers stated above. Charges at the publish rate will be imposed on non-cardholders. You may purchase a lounge use package at a 20% discount from the published rate with your Bank Islam Credit Card-i.

7. Is there any age limit for the Plaza Premium Lounge access?

- There is no age limit for the Plaza Premium Lounge access and admission is free for children aged below 2 years old. Any accompanying guest (aged 2 or above) shall be entitled to a 20% discount off the listed price for the entrance fee and the payment shall be settled by Cardholder on the spot.

8. How long can I stay at the Plaza Premium Lounge per visit?

- You can enjoy complimentary lounge access for a maximum of 3 hours per visit. Facilities may differ for each outlet. Please check www.plaza-network.com for details.

9. Can I stay in the lounge longer than 3 hours per visit?

- Please check with Plaza Premium lounge staff for availability when you check in to the lounge.

- No advance booking is required. However, cardholders are advised to check with the respective Plaza Premium outlet as their services are subject to availability.
